TERMS AND CONDITIONS:

The Buyer (herein called Member) does hereby make application to Quickie's Quality Car Wash (herein called QQCW) for Membership to the Club Program designated by the Member as referenced in this agreement and hereby agrees to comply with and be bound by the terms and conditions, as they currently exist and may from time to time in the future be amended or supplemented. The Member authorizes and agrees to pay the monthly dues for the Membership selected on this agreement, which are subject to increase as described below. Membership is only valid only for the vehicle enrolled on this agreement.

Sorry, Fleet, Commercial or Livery vehicles are NOT eligible for Unlimited Membership. Please inquire about Fleet Cards.

By executing the Membership agreement you have authorized QQCW to make withdrawals from or apply other related and agreed upon charges to the account you have specified for Membership dues. Debit entries that are returned by bank or credit card provider are subject to a return check/item charge of \$25.00 or the maximum amount allowed by state law. Such returned check/item charge shall be automatically deducted from the account indicated herein. You further indicate by your signature as Buyer, that you are authorized signatory of the account specified for use in the collection of those same dues and fees. You understand that the above authority is to remain in force and in effect for the recurring monthly payment amount as indicated in this Agreement, on a recurring Monthly basis, or until such time as (1) QQCW terminates the program or (2) QQCW receives written notification from you informing us of your intent to terminate the Membership. In any event, QQCW will act promptly to stop further debit entries within a reasonable period of time herein defined as no longer than 5 days from the date QQCW receives such written notice. The aforementioned cancellation notification requirements are applicable to all Memberships.

MONTHLY DUES: Will be collected each month regardless of the Members usage of the car wash until we are notified, in writing that you wish to cancel this Agreement. Regardless of such cancellation, any outstanding balance of the Membership fee will remain due and payable in accordance with this Agreement. Failure to pay any monthly dues payment within 2 days after the date such payment is due, your Membership privileges may be canceled and you may have to reapply for Membership under new terms and dues QQCW is then charging new Members. There are no annual maintenance dues. Any Buyer wanting to join Club Membership for 1 month only, paying cash or credit/debit card, will be charged an additional \$5 processing and handling fee per month.

***ADDITIONAL CAR DISCOUNT:** Additional car discount valid only if same club member has an active primary first car membership paying full price within same wash package category level. If primary first car membership is cancelled or membership category level reduced, then additional car discount will be void and membership will be billed at the selected full membership category price thereafter.

CANCELLATION: The Member, with written notification and return of the electronic RFID windshield tag issued, may cancel this Agreement at any time prior to midnight of the third business day following the execution date, not including Sundays and holidays and will receive a full refund of all monies paid to QQCW but limited to the initiation and first months dues, less the value of any washes already taken. After the three days, Members can cancel or change wash plans by notifying QQCW in writing by email at accounts@quickiescarwash.com or US Mail with proof of delivery to 2197 Sampson Ave., Corona, CA 92879, received by QQCW at least 5 days prior to the Billing Date. Recurring Billing Date is determined to be the day of the month Member purchases membership or re-purchases membership. There is no proration for early termination, but member can continue to use membership until it expires up to the Billing Date. Any cancellation notices received by QQCW less than 5 days prior to Billing Date, will be billed and cancelled the following month. Member agrees no refunds or credits will be issued for little or no use of membership.

BILLING ERRORS: Member understands and agrees to check their bank card statements every month and to notify QQCW of any billing errors immediately upon receiving monthly bank card statement in writing by email at accounts@quickiescarwash.com or US Mail with proof of delivery. Member agrees that any adjustments or refunds are limited to 30 days prior to QQCW receiving written notification. Member also agrees to notify in writing and try to resolve first with QQCW before filing a bank card dispute or they agree to be billed on their bank card any chargeback fees QQCW incurs.

ONE CAR PER MEMBERSHIP: Only the car listed on this form is eligible for the program and MUST have a QUICKIPASS RFID Membership tag affixed to the front windshield. Damaged tags should be reported to QQCW immediately. If RFID Membership tag is not affixed to windshield, membership will be cancelled immediately without recourse. Any attempt to remove the tag will destroy the tag and prevent it from operating. The member will be charged a \$3.00 fee for tag replacement due to member's actions.

GOVERNING LAW: The laws of the State of California, in which this Agreement is signed, and to the extent preempted by federal law, govern this Agreement.

MISCELLANEOUS: The provisions of this Agreement are several and if any provisions are determined to be illegal or unenforceable the remaining provisions and any partially enforceable provisions shall nevertheless be enforceable unless otherwise prohibited by state law. Our failure to enforce any remedy or provision of this Agreement shall not be construed as a waiver of such remedy or provision including, but not limited to, yearly increases in monthly dues permitted pursuant to the terms and conditions of this agreement, which can be imposed cumulatively at any time. AGREEMENT, YOU ACKNOWLEDGE RECEIPT OF A FULLY COMPLETED COPY OF THIS AGREEMENT EXECUTED BY BOTH YOU AND QQCW AND A COPY OF THE TERMS AND CONDITIONS.
